Virgar Hvidbro, sum í gjár varð settur sum aðalskrivari, sigur at Fótbóltssambandið arbeiður við málinum um Sorin Anghel. Fótbóltssambandið hevur ongantíð áður verið í einari líknandi støðu fyrr, so Sorin Anghel málið er eitt fordømi

- Vit hava sett okkum í samband við løgregluna og spurt um mannaongdir í samband við eitt slíkt mál, sigur Virgar Hvidbro.
Sum skilst, so kann tað koma at ganga rúm tíð áðrenn Sorin Anghel fær føroyskt pass.
- Vit høvdu eisini nakrar trupulleikar við onkrum av U-21 landsliðsleikarunum. Onkrir av teimum høvdu ikki danskt/føroyskt pass og

tað skulu teir fyri at kunna umboða Føroyar, sigur Virgar Hvidbro.
Her var talan um millum annað Rógva Baldvinsson, sum skoraði eitt av málinum, tá U-21 landsliðið vann 3-1 á Andorra í Gundadali í síðstu viku.
- Nú bíða vit eftir svari úr Danmark, men annars kann eg bara vísa til reglugerðina hjá FIFA, sigur Virgar Hvidbro at enda.



“17 Acquisition of a new nationality

Any Player who refers to art. 15 par. 1 to assume a new nationality and who has not played international football in accordance with art. 15 par. 2 shall be eligible to play for the new representative team only if he fulfils one of the following conditions:

- (a) He was born on the territory of the relevant Association;
- (b) His biological mother or biological father was born on the territory of the relevant Association;
- (c) His grandmother or grandfather was born on the territory of the relevant Association;
- (d) He has lived continuously for at least five years after reaching the age of 18 on the territory of the relevant Association. “

Sambært reglugerðini hjá FIFA, so kann ein leikari, ið hevur búið í einum nýggjum landið í fimm samanhangi árum eftir at verða fylltur 18-ár, søkja um at umboða hetta nýggja landið. Tað inniber tó, at leikarin ikki hevur umboðað sítt fyrsta land í einum altjóða dysti.
Tað er eisini sambært reglugerðini hjá FIFA bara loyvi at skifta landslið eina ferð. Samstundis skal leikarin senda ein skrivligan fyrispurning til FIFA, sum har eftir tekur fyrispurningin til viðgerðar og avgerð, um leikarin kann skifta.

Niðurstøða:

Eftir steypafinaluna skrivaði Dimmalætting, at Sorin Anghel var blivin danskur ríkisborgari. Um so var, so hevði Brian Kerr kunna uttikið Sorin Anghel, men tað er ikki stóðan hjá Sorin Anghel. Hann hevur fingið permanent visum, sum ikki er tað sama.
Fleiri røddir hava spurt hví

Sorin ikki var á landsliðnum í Estlandi, tá so nógv avboð vóru, men sannleikin er tann, at Sorin Anghel ikki hevur loyvi at spæla við føroyska landsliðnum - enn.
Tað er ongin ivi um, at Brian Kerr fegin vil hava Sorin Anghel á føroyska landsliðið, men sum nú er, so bíða øll eftir svarið úr innanríkisráðnum.

“18 Change of Association

1. If a Player has more than one nationality, or if a Player acquires a new nationality, or if a Player is eligible to play for several representative teams due to nationality, he may, only once, request to change the Association for which he is eligible to play international matches to the Association of another country of which he holds nationality, subject to the following conditions:
69 VII. ELIGIBILITY TO PLAY FOR REPRESENTATIVE TEAMS
(a) He has not played a match (either in full or in part) in an official competition at “A” international level for his current Association, and at the time of his first full or partial appearance in an international match in an official competition for his current Association, he already had the nationality of the representative team for which he wishes to play.

- (b) He is not permitted to play for his new Association in any competition in which he has already played for his previous Association.
- 2. If a Player who has been fielded by his Association in an international match in accordance with art. 15 par. 2 permanently loses the nationality of that country without his consent or against his will due to a decision by a government authority, he may request permission to play for another Association whose nationality he already has or has acquired.
- 3. Any Player who has the right to change Associations in accordance with par. 1 and 2 above shall submit a written, substantiated request to the FIFA general secretariat. The Players’ Status Committee shall decide on the request. The procedure will be in accordance with the Rules Governing the Procedures of the Players’ Status Committee and the Dispute Resolution Chamber. Once the Player has filed his request, he is not eligible to play for any representative team until his request has been processed.”

Grein 18 sigur millum annað, at leikarin ikki má hava umboðað sítt fyrra land í einum A-landsdysti framman undan. Tað stendur eisini, at meðan fyrispurningurin er til viðgerðar, so kann leikarin hvørki umboða sítt fyrra fótbóltssamband ella tað fótbóltssambandið, ið leikarin ynskir at gerast knýttur at.
